3. FTAPCCI will arrange to provide periodic field visits to faculty and students of Avanthi Educational Society at its project sites/Factories of FTAPCCI members to enable them to get practical exposure and learning from interaction
4. FTAPCCI may offer specific assignments (case studies on industrial issues, sample surveys and data collection, presenting papers and publication in leading journals as joint publication) with identified deliverables to be executed by Avanthi Educational Society. Detail modalities including financials would be mutually worked out for each assignment.
5. All students & faculty of Avanthi Educational Society can join any free program organized by FTAPCCI. For paid programs FTAPCCI will offer 20% discount on the offered fees.

General Conditions:

1. FTAPCCI and Avanthi Educational Society shall designate one of its employees as the Coordinator. The Coordinator shall act as the administrative liaison in implementing the terms of this agreement.
2. The Coordinator shall be responsible for cooperating to assure mutual participation and supervision of the program.
3. The Coordinators shall be responsible for periodically review and identify ways to disrupt the operations and services of any of the parties.
4. FTAPCCI and Avanthi Educational Society agree to fulfill the obligations of this MOU in such a manner that it would not disrupt the operations and services of any of the parties.
5. This MoU begins on the effective date and expires on mutually agreed date with a notice period of six months, unless terminated earlier, in accordance with the MoU.

6. This MoU in no way restricts the FTAPCCI & Avanthi Educational Society from participating in similar activities with other private or public agencies, organizations or individuals.
7. Avanthi Educational Society and FTAPCCI recognize the shared responsibility they have with each other to abide by various regulations.
